1. 被保険者負担分に1円未満の端数が出る場合(通貨の単位及び貨幣の発行等に関する法律)
①事業主が給与から被保険者負担分を控除する場合→被保険者負担分の端数が50銭以下の場合は切り捨て、50銭を超える場合は1円に切り上げます。
②被保険者が被保険者負担分を事業主に現金で支払う場合→被保険者負担分の端数が50銭未満の場合は切り捨て、50銭以上の場合は1円に切り上げます。
*上記にかかわらず、事業主と被保険者の間に特約がある場合は、特約に基づいて端数処理を行います。
2. 納入告知書の告知額について(国等の債権債務等の金額の端数計算に関する法律)
告知書額は、事業所ごとに被保険者の保険料額を合算した金額になります。ただし、合算した金額に1円未満の端数が生じる場合は、その端数を切り捨てます。
3. 賞与に係る保険料が生じる場合
賞与に係る保険料が生じる場合は、月分の保険料と賞与分の保険料を合算した金額になりますが、この合算額について2の端数処理を行います。
